#### CALL TO ORDER.

CID Director David Potter reported for following results for compliance checks

December FY 24 - 31 / 342 = 9 06 % January FY 24 - 29 / 373 = 7 78 % February FY 24 - 31 / 433 = 7 16 % FY 2024 - 252 / 3,288 = 7 66 %

Results for Inspections for the month of February 2024, with 14 out of 23 inspections totaled 34 violations = 60.9%

### FDA ACTIVITY

Deputy Director Ray Owens reported for the month of February 2024 FDA Agents completed 270 routine inspections with 16 potential violations resulting in a 5 9% violation rate for the month of February FDA Agents completed 95 follow-up Inspections with 3 potential violations resulting in a 3 16 % violation rate for the month of February 2024
